### a. SHOW BUS Presentation

## b. Regional Housing Initiative update

Mr. Lai spoke about Salvation Army Homeless Shelter reopening for in-take on November 14. Winter months are causing shelters to be overcrowded. MCRPC staff is part of a subcommittee regarding making warming centers more available during extreme low temperatures.

The 2022 white paper for "Income-Qualified Housing Issue 2: Type of Units and Vouchers" has been approved by the Regional Housing Staff Committee and posted on MCRPC website. Currently, data shows that McLean County has 2,435 income qualified housing units and 640 housing choice vouchers.

The second round of Illinois Emergency Homeowner Assistance Fund is open until January 31, 2023 by IHDA. Applicants may apply to receive up to \$30,000 in assistance. Applicants who applied in the first round, may apply again.

Mr. Burrill asked if the information is available on our website or IDHA's website. Mr. Lai explained it is on IDHA's website.

### c. Vision Zero/Go:Safe McLean County Action Plan Project update

Mr. Lai advised that MCRPC staff is working on the grant agreements with IDOT for the Bike and Pedestrian safety grant and a transportation safety grant MCRPC was awarded. Staff should hear about the federal SS4A grant application in January.

Mr. Lai indicated that MCRPC is currently hiring an Assistant Planner position, after Ana Mendoza got a job working for McLean County IT.
