1. Call to Order

3. Public Comment

4. <u>Minutes</u>

Mr. Stokes offered a motion to approve the minutes of the June 26, 2020 meeting, and was seconded by Mr. Aldrich. The motion was unanimously approved.

5. <u>Approval of Amendment #1 to the FY 2021-2025 Transportation Improvement</u> <u>Program</u>

Mr. Neihart advised that the Amendment consists of the addition of District 5 project no. MBPM 2021-1, for bridge joint replacement or repair of the I-55/I-74 bridge over Raab Road in north-west Normal, with a total cost of \$223,000 in FY 2021.

Mr. Kothe offered a motion to approve Amendment #1, and was seconded by Mr. Stokes. The motion carried unanimously.

6. Approval of Amendment #2 to the FY 2021-2025 TIP

Mr. Neihart advised that the Amendment consists of the addition of District 5 project no. BP 2021-1, for bridge painting at 4 structures in Bloomington-Normal, located on Interstates 55 and 39, with a total cost of \$1,500,000 in FY 2021.

Mr. Kothe offered a motion to approve Amendment #2, and was seconded by Mr. Stokes. The motion carried unanimously.

7. Approval of Amendment #3 to the FY 2021-2025 TIP

Mr. Neihart advised that the Amendment consists of the revision of District 5 project no. C086 in FY 2022, for sealing on US 150 from Illinois Rt, 9 to the Woodford County line, and using rural STP funding, at a total cost of \$2,180,000.

Mr. Stokes offered a motion to approve Amendment #3, and was seconded by Mr. Kothe. The motion carried unanimously.
